Philip J. (P.J.) Brooks, Ph.D., is the deputy director of NCATS' Division of Rare Diseases Research Innovation. Brooks represents NCATS in the NIH-wide Gene Therapy Working Group, the Regenerative Medicine Innovation Project and the International Rare Diseases Research Consortium (IRDiRC). He also is the working group co-coordinator for the NIH Common Fund program on Somatic Cell Genome Editing, one of the leaders of the Platform Vector Gene Therapy (PaVe-GT) pilot project and the co-chair of the Bespoke Gene Therapy Consortium.

John M. Conley is William Rand Kenan, Jr. Professor at the UNC School of Law. He received his law degree and Ph.D. (Anthropology) from Duke, where he was editor-in-chief of the *Duke Law Journal*. After practicing in Boston and Charlotte, he joined the UNC law faculty in 1983. He teaches several courses involving the intersection of science and the law. Conley's research interests include the anthropological study of institutions and organizations, including law firms, investment organizations, corporations, and scientific enterprises, and the application of intellectual property law to emerging technologies. His current research project, conducted in



collaboration with UNC's Center for Bioethics, is examining the governance of new gene editing technologies.
